If you are trying to raise money for World Youth Day, Mission Trips, parish pilgrimages or other events, this program is quick, easy and fun. We are making the DVD available on consignment for a limited time.

Here are 4 easy steps to bringing this to your parish:

1. Read the Terms below.
2. Complete the Consignment Agreement (Signature must come from Pastor or authorized member of the parish staff).
3. Print authorization statement on parish letterhead.
4. Fax to 1-866-232-3470.

The terms and conditions of the program are as follows:

Terms of the Program

Price: Parish Bulk Price is \$10.00 with a published retail price of \$19.95 on the DVD. The parish will cover the cost of shipping books to participating parishes and parishes are responsible for returning unsold DVDs back to Champions of Faith at the end of the program. All returned DVD's need to be unopened and in resellable condition.

Full-size posters are available for \$8.00 (20% discount) and retail for \$10.00 each. These must be purchased at the time of order and are not available for consignment. One free poster comes with each order of 500.

Promotional kits which include bookmarks, postcards and mini-posters are available for free. The only cost for parishes is shipping. Please refer to the *Champions of Faith* website for shipping prices on various kits. One free kit is included with each order of 100.

Duration: The consignment program will run for 30 days. Parishes can order DVDs for parish-based events or fundraisers (youth groups, KOC, Men's Groups, Athletic Clubs, ministry departments, galas, parish missions, etc). We ask that promotion of the sales events in the parishes occur prior to the shipping of the DVDs to ensure enough time for promotion within the parish. You will have four (4) weekends to sell the DVDs. All remaining DVDs need to be returned to Champions of Faith by the week following the fourth weekend of the program. As a courtesy, Champions of Faith or our agent, The Maximus Group, will contact participating parishes to confirm the number of DVDs sold prior to billing. Parishes will be billed for all unreturned DVDs within ten (10) days of the conclusion of the program. DVD's should be returned to Champions of Faith Fulfillment (address provided below).
